## Unit No 6 Fishing Industry

## Lesson is about Problems of the Fishing Industry in Pakistan.

#### Inquiry:

What are the problems of fishing industry in Pakistan? How these problems are solved? What is meant by sustainable fisheries?

## Information

#### **Problems in the Fishing Industry:**

#### Environmental:

- Subsoil water is frequently pumped out to fill these farms, which lowers the water table.
- When water evaporates from them, salinity is caused.
- Ecological:
- The conversion of coastal wetlands into nurseries has affected the many organisms living in these nutrient-rich marshy lands.

#### **Pollution:**

- Discharge from fish farms may contain chemicals used for disinfecting and hormones used for the breeding of fish which adversely affect other organisms.
- There is pollution on the coast (mostly in Karachi).
- Spillage of oil harms fish. There are other pollutants, too.
- Many chemicals with witch carcinogenic qualities and toxic materials/heavy metals such as cadmium, aluminium, and nickel have been found in marine life.
- These can enter the food chain and affect the people who eat them.
- The rivers of Pakistan are also polluted.
- Chemicals used in agriculture leak into the river system.
- Domestic waste is dumped into rivers.

## Mangroves:

- They are a breeding ground for many species.
- They protect the coastlines from tide.
- Development of fishing on the coastlines will threaten them.

## Overfishing:

- Fishing is conducted throughout the year, even during the breeding season, especially by foreign trawlers.
- This limits the production of fish.
- This is made worse by the usage of illegal nets which have small holes which allow them to catch baby fish.
- In order to prevent this, marine fishing will have to be banned in June and July, which would affect profits. <u>Economic:</u>

Cost:

- There is a lack of skilled labour in Pakistan, all of whom will have to be trained
- Pakistan does not have enough money to develop the fishing industry
- Lots of capital and skilled labour is requiring for training and machinery
- Money has to be spent on technology
- Profit is also reduced when you share profits with boats from other countries which fish here **Foreign Exchange:**
- There is a chance that it will not be reimbursed due to international restrictions on the export of fish
- Most of the technology will have to be imported
- Many batches of fish are rejected since if one is found to be rotten, the whole delivery is thrown away **Restrictions:**
- Controls on net size and fishing during fishing season to prevent overfishing **Income**:
- Fishing does not provide a high profit or large income for fishermen. **Sustainability:**

In order to promote fisheries on sustainable lines:

- Deep-sea trawlers shouldn't be allowed to operate in the Pakistani section of the Arabian sea to prevent overfishing
- While illegal nets have already been banned, this ban needs to be enforced
- Regulate water pollution and the cutting of mangroves
